VI UPDATE FROM OUR STATE PARTNERS

Anecita Agustinez, Department of Water Resources

- DWR recently hosted the Tribal Regional Water Management Webinar 3-Part Series on the past and future of Integrated Regional Water Management (IRWM) and the challenges and successes experienced by tribes. The meeting materials and recordings are posted here: http://facilitation-team.org. There was great participation from tribal and non-tribal partners, as well as the state. Thank you to Leaf Hillman for his support and participation in a panel discussion, along with Karen Gaffney. Thanks as well to Sherri Norris and Javier Silva, who were excellent co-facilitators. The goals of the 3-day meeting were to find ways to duplicate success with past IRWM grant round and to maintain Tribal involvement/engagement in anticipation of Round 2 in 2022 (\$13 million available). All meeting materials will be made available; it is hoped that they will reach new tribal partners to help them understand where IRWM has been and where it is going. Participants also discussed Sustainable Groundwater Management Act (SGMA) issues and concerns were aired directly to executive leadership through this forum. A proceedings document and reference guide will also be produced as well as a workbook on grant processes, which DWR would like to share with TPRC/PRP for review.
- One of the biggest success stories of the NCRP is having a Tribal engagement Coordinator as part of its structure. The question is whether Tribal coordinators could be implemented statewide.
- DWR has also been meeting with several tribes in the Delta conveyance area, although COVID has delayed some of this consultation. An update will be provided on this and all of the above soon.

VII NCRP REGIONAL FOREST AND FIRE CAPACITY PROGRAM REPORT

Karen Gaffney provided an update on the overall RFF program and selection of technical consultants and forest advisors. A written update with more detailed information is provided in the meeting materials.

- The PRP approved a suite of Round 1 demonstration projects at the last quarterly meeting in April and will approve Round 2 today, following a presentation by the TPRC Co-chairs.
- Humboldt County staff has been working with the Round 1 subgrantees to develop detailed scopes and conducting kickoff meetings to discuss integration with the RFFC project and NCRP's goals.
- The Round 1 projects are expected to be under contract by end of June.
- NCRP staff has also been working with the Round 1 subgrantees to develop ideas on how to incorporate their projects into the Regional Priority Plan (RPP). Initial ideas include: videos, posters, or multi-page spreads
- As for the RPP itself, the draft plan outline continues to be developed following guidance of the PRP and
 Forestry Ad Hoc. Several consultants have been brought on board to assist with its development, including
 several registered professional foresters and academic policy experts.
- Staff are planning to issue an RFP for technical assistance and are currently developing an approach.

- Now that the technical consultants, forest advisors, and demonstration project proponents have all been identified, staff plan to convene a regional mapping meeting to coordinate geospatial data sharing and collection efforts.
- Staff are also working with consultants and advisors to develop a methodology for developing a list of prioritized projects to be incorporated into the RPP. Some of these projects may also be eligible for technical assistance under the RFFC project.
- Sherri Norris announced the names of the tribal consultants and tribal forest advisors currently on board; she noted that the search process for additional tribal forest advisors is ongoing:

VIII NCRP TRIBAL & COUNTY FOREST ADVISORS ANNOUNCEMENT

NCRP PRP Chair Morris explained that the Tribal and County Forestry Advisors will play an important role reviewing and advising on the Regional Priority Plan and the development of a technical and capacity assistance program. The Forest Advisors that have been selected so far are as follows:

IX NCRP REGIONAL FOREST & FIRE CAPACITY DEMONSTRATION PROJECT SOLICITATION, ROUND 2

NCRP PRP Chair Judy Morris thanked TPRC Co-chairs Sandra Perez and Dale Roberts for their leadership and guidance of the TPRC through the selection process.

TPRC Co-Chair Dale Roberts, Sonoma Water described the recent project review process and presented the Technical Peer Review Committee recommended suite of NCRP 2020 Round 2 Demonstration Priority Projects.

He explained that a total of \$1.8 million of the CNRA block grant funding will go to fund demonstration processes and on-the-ground projects designed to test concepts, methods, and innovative techniques to identify effective management practices for fuel load reduction and forest health. All demonstration projects need to be completed by July 2021 to ensure integration of lessons learned and project results into the RPP. Round 1 (the first of two rounds of funding) was allocated by the PRP on April 3; six projects were funded at a cost of \$916,421 including 6% for administration and project management. NCRP staff are now working closely with the subgrantees to develop their budgets and scopes of work in a way that is responsive to TPRC comments as well as the objectives of the RFFC project and NCRP as a whole.

For Round 2, the NCRP received 15 project proposals for a total request of approximately \$2.7 million, on May 22. The TPRC reviewed the concept proposal for the next couple of weeks and on Monday, June 15, the TPRC met via conference call to discuss the project proposals and select a draft suite of Priority Projects. A total of 9 TPRC members participated in the almost 6-hour conference call. The conversation was professional and informed and resulted in the following TPRC recommendation that funds seven of the top eight ranked projects at a cost of \$883,579 (including 6% admin).

Discussion:

- Dale Roberts offered the following reasoning for several decisions made:
 - The TPRC decided not fund the Klamath Meadow Restoration Planning Demonstration Project despite its high ranking because the Scott River Watershed Council (project proponent) would already be receiving funding for an even more highly ranked project; two additional projects could be funded in its stead, thereby providing wider regional representation consistent with the PRP direction provided during the first solicitation process; and, these two additional projects were within one point of the Klamath Meadow project.
 - The TPRC did not recommend funding of more than \$200,000 for any one project, which is consistent with the highest amount allocated in Round 1. Lowering the maximum amount given to any one project increased the number of funded projects.
 - Once the subgrantees accept the funding, NCRP staff will begin working with them on their scopes of work to ensure the best integration with the RFFC project and NCRP's goals.
- Supervisor Madrone: Humboldt Redwood Company proposal seems like the activities proposed would fall under the Habitat Conservation Plan. What was the thinking behind funding this project? The funding might be better spent on a project for Siskiyou County, which hasn't had many projects funded over the years. The TPRC Co-chairs replied by making the following points:
 - a. That the project proposal stated that it was cost prohibitive to treat slash in a way that would encourage forest health and oak regeneration. This project proposed to illustrate how a more innovative approach could be applied in a cost-effective way.
 - b. They lowered their ask substantially from Round 1 and are offering over 100% match.

PUBLIC COMMENT

Pat Higgins, ERRP: Very pleased to have been selected and to have the opportunity to work on forest health for Mendocino County. The EERP project will enable access to CCI funding, improve fire safety, oak regeneration, increase flow of Tenmile Creek, and create a carbon sink within this watershed. Also, thank you to DWR for funding another water project in the area.

Raymond Baltar, SEC: Thank you to NCRP. Very much looking forward to showcasing what the biochar kilns can do. Lessons learned will benefit the whole NCRP region. Kilns will be shared with other groups as well.

Cybelle Immitt, Humboldt County

A detailed report on the status of the projects and grant rounds administered by the County of Humboldt is included in the meeting materials. Prop. 84 Round 1 has officially been closed out. A big thank you is owed to Denise Monday for seeing it through to completion and to Eric Martinez for his support as DWR grant Manager. Denise has also been instrumental in setting up the Prop. 1 Round 1 grant round. Also, thank you to Julia Cavalli for taking on the role of lead administrator for the RFFC Demonstration Projects.

Notable Legislation

Grant Davis, Sonoma County Water Agency

COVID-19 has cast uncertainty on the state budget and on continued funding for NCRP. A resiliency bond was being planned for the November ballot but this is no longer possible. NCRP will need to redouble efforts to leverage local dollars and find other means to fund projects like those approved today. Agencies and partners are supportive and understanding. Executive committee had planned to call on legislators this spring to seek additional funding but this too, will not be possible this year.
