DOC EDA FY 2019 EDA Disaster Supplemental - \$587 million. EDA announces general policies and application procedures for the Disaster Supplemental NOFO. Subject to the availability of funds, this investment assistance will help communities and regions devise and implement long-term economic recovery strategies through a variety of non-construction and construction projects, as appropriate, to address economic challenges in areas where a Presidential declaration of a major disaster was issued under the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. § 5121 et seq.) (Stafford Act) "as a result of Hurricanes Florence, Michael, and Lane, Typhoons Yutu and Mangkhut, and of wildfires, volcanic eruptions, earthquakes and other natural disasters occurring in calendar year 2018, and tornadoes and floods occurring in calendar year 2019...". <u>USDA NRCS Emergency Watershed Protection.</u> The Emergency Watershed Protection Program allows communities to quickly address serious and long-lasting damages to infrastructure and to the land. The EWP Program authorities offer NRCS the flexibility to act quickly to help local communities cope with adverse impacts resulting from natural disasters. EWP does not require a disaster declaration by federal or state government officials for program assistance to begin. The NRCS State Conservationist can declare a local watershed emergency and initiate EWP program assistance in cooperation with an eligible sponsor (see the "Eligibility" section below). NRCS will not provide funding for activities undertaken by a sponsor prior to the signing of a cooperative agreement between NRCS and the sponsor.

<u>California State Library Broadband Support Grants.</u> The State Library is continuing and expanding its High-Speed Broadband for California Libraries Grants programs. Beginning in April of 2019, the program is expanding opportunities for qualified/eligible public libraries to apply for funding in the following areas:

- First year connection costs
- Equipment to support connections
- Consulting costs related to configuration and installation of equipment
- Construction costs related to expansion of necessary infrastructure to make connections
- Construction costs related to required upgrades of inside wiring and other facilities to make connections viable
- Technical network training for librarians

Libraries that have previously received support from the State Library may be eligible for additional funds. All grant application deadlines are now rolling.

DOI Bureau of Reclamation, WaterSMART Grants: Water Marketing Strategy Grants. The objective of this NOFO is to invite States, Indian tribes, irrigation districts, water districts, and other organizations with water or power delivery authority to leverage their money and resources by cost sharing with Reclamation to develop a water marketing strategy to increase water supply reliability. Applicants under this NOFO may request funding to develop a water marketing strategy (project) to establish or expand water markets or water marketing activities. A "water marketing strategy" is a framework for implementation of water marketing activities. Reefense, DOD Biological Technologies Office. Reefense seeks to develop self-healing, hybrid biological and engineered reef-mimicking structures to mitigate the coastal flooding, erosion and storm damage that increasingly threaten civilian and DoD infrastructure and personnel. Under Reefense, custom wave-attenuating base structures will promote calcareous reef organism (coral or oyster) settlement and growth, which will enable the system to self-heal and keep pace with sea level rise over time. A system will be put in place that will also attract non-reef building organisms necessary to help maintain a healthy, growing system. Finally, adaptive biology (other than genetically modified organisms) will enable improved coral and oyster resilience against disease and temperature stress, to ensure compatibility with a changing environment. <u>Urban and Community Forestry Challenge Cost Share Grant Program.</u> The USDA Forest Service Urban & Community Forestry (U&CF) Program restores, sustains, and manages more than 140 million acres of urban and community forest lands for the benefit of communities in the United States. Increasingly, our urban and community forests are facing threats such as insects, diseases, extreme weather events and other hazards. Additionally, the lack of investment in urban forest disaster mitigation is contributing to community disasters such as urban flooding and human heat deaths in our cities—disproportionately affecting <u>vulnerable</u> <u>populations</u>. New systemic solutions are needed to create and enhance green infrastructure in the right place and at the right scale and encompass pressing social, economic, ecological, and historic factors holistically.

Rose Foundation California Wildlands Grassroots Fund.
