- The next <u>Tribal NCRP Meeting on August 25 2022 at 10am</u> in online where your identified <u>Voting Delegate</u> will assist in selecting new Leadership Council and TPRC Representatives for your District.
- The next Quarterly NCRP Meeting is on August 26, 2022. If your Representative is selected they should be prepared to attend this meeting.

This 'Nomination Form' is for Tribal Councils to nominate a person, or persons to join the governance bodies of the North Coast Resource Partnership (NCRP), in accordance with the attached 'Tribal Representation & Selection Process' document.

The NCRP is the regional body originally created to manage the funding from the state's Integrated Regional Water Management (IRWM) program. County and Tribal Representatives make up the decision-making body of the NCRP. Additional projects supporting our objectives have been added to the North Coast workplan, including those of the new Regional Forest and Fire Capacity (RFFC) Program. In 2010 the North Coast Resource Partnership (NCRP) amended their governing body to include Tribal representation in their Technical Peer Review Committee (TPRC) and the Policy Review Panel, now renamed he Leadership Council. North Coast Tribes conduct their own selection process for Tribal representation.

Six (6) seats have been allocated to Tribes within the North Coast IRWMP region. These consist of three (3) Leadership Council seats and three (3) Technical Peer Review Committee seats, and an alternate for each. This means there is a team of twelve (12) Tribal Representatives making decisions by consensus, and then three (3) join county Representatives in the Leadership Council at Quarterly and Executive Committee meetings to guide the NCRP.

To be seated as a NCRP Tribal Representative the NCRP MoMU needs to be signed by the new Representative's Tribe and the Tribe must formally adopt the North Coast IRWM Plan. This is also a requirement for all NCRP project applicants to receive IRWM funding.

Decision making alongside the seated County representatives requires a quorum is present; therefore a Tribal Representatives from each District or their Alternates are responsible to attend all meetings for the Leadership Council and/or TPRC seat for which they were nominated. If Representatives are unable to attend a meeting, they must inform their Alternate and the Tribal Engagement Coordinator at least two (2) weeks prior to the meeting to make arrangements for Alternate or TPRC participation. This will ensure that Tribal Representatives are at the table for decision-making.

For those Tribes requiring financial assistance in order to participate, there are some funds available. For more information please also see the attached *'Tribal Selection & Representation'* document.

The 'Tribal Selection & Representation' document also contains complete list of Leadership Council and TPRC Representative Roles and Responsibilities and the list of NCRP Districts and Tribes within them.
