The next <u>Tribal NCRP Meeting on October 17, 2024 begins at 10am</u> at Elk Valley Rancheria, 2332 Howland Hill Road, Crescent City, CA. That is where your identified <u>Voting Delegate</u> will assist in selecting new Leadership Council and TPRC Representatives for your District.

The next Quarterly NCRP Meeting is the following day on October 18, 2024, where new Representative are announced. If your Representative is selected they should be prepared to attend this meeting.

This 'Nomination Form' is for Tribal Councils to nominate a person, or persons to join the governance and technical review bodies of the North Coast Resource Partnership (NCRP). North Coast Tribes conduct their own selection process for Tribal representation.

The NCRP is a regional body of Tribal and County representatives choosing which applicants are funded and providing guidance on NCRP programs that offer technical assistance, capacity-building, training and funding for programs related to watershed, forest and fire, waste water and climate resiliency.

Tribal seats within the North Coast region consist of three (3) Leadership Council seats and three (3) Technical Peer Review Committee seats, and alternates for each. Of these, three (3) Leadership Council representatives join county Representatives at Quarterly and Executive Committee meetings to make official decisions for the NCRP. TPRC representatives review proposals and provide recommendations to Leadership Council of which proposals should be funded.

Decision making alongside the seated County representatives requires a quorum is present; therefore a Tribal Representatives or an alternate from each District are responsible to attend all meetings for the Leadership Council and TPRC for the seat for which they were nominated.
